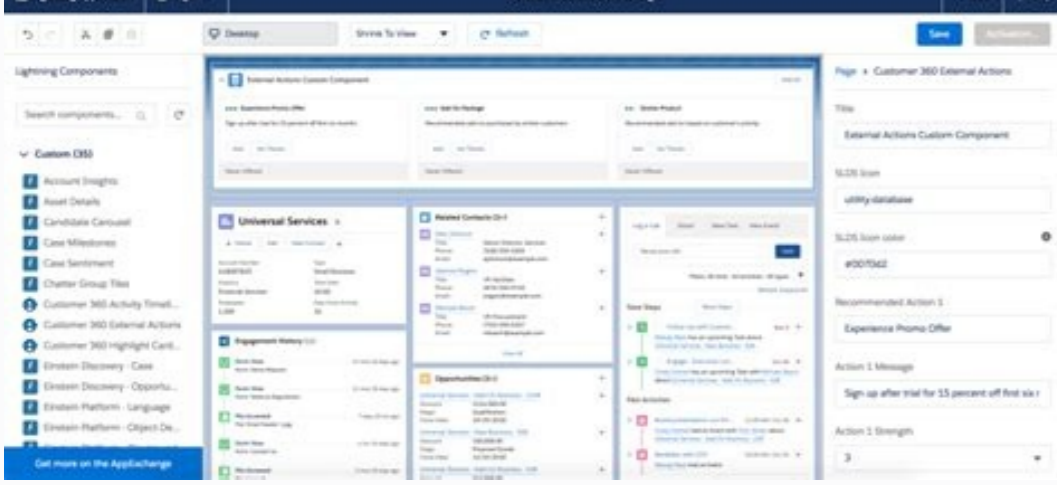

It offers a free and easy way to make sure you always have a backup of your precious online data. I could go to each site and download all of my files until I've amassed an offline collection of my stuff. For example, SocialFolders uses Facebook's default upload API, which can reduce photo resolution. Depending on the state you reside in, you will be eligible to apply for unemployment benefits online, in person, on the phone or by mailing in a claim form. Long story short, where you're currently residing might not be the state that will pay you unemployment benefits if you haven't lived there long. These steps may take place as you're filing your application, or they could be the last steps in determining your eligibility. If you have any difficulty locating your local center, contact your state unemployment agency for assistance. -Liane Cassavoy Moreover, if you willingly quit your job, are an independent contractor or otherwise self-employed, or can't go back to work for health or other reasons, you might not qualify. These state-run agencies give people access to job listings and career training resources, and registration is mandatory to receive your unemployment insurance benefits. SocialFolders is not only limited to downloads; It lets you upload files to your social sites, too. (The free version of SocialFolders limits you to three services and 2,000 files; a Premium account, which costs \$10 per year, is unlimited.) SocialFolders organizes your Facebook photos into folders that correspond with your album names, and photo titles that correspond to your captions. Once you've connected SocialFolders to your social services, icons for each of them will appear in the SocialFolders folder that's been created on your computer. Subfolders for each of your connected services will automatically be created there, too. I have documents stored in Box. By the end of April, a staggering 30 million Americans had filed for unemployment benefits. If you fail to answer the questions correctly — or don't consent to this process — you will most likely be asked to provide the agency with documents that verify your identity. Step 4: File Your Claim Once you confirm your eligibility, it's time to file your claim. Additionally, if your application is denied for any reason, you have the right to file an appeal to try to overturn the denial. Step 3: Verify Your Identity During the initial application process, each state's unemployment division will ask you to verify and authenticate your identity. I did notice that some of the photos that SocialFolders downloaded for me looked to be slightly lower res than they appeared when viewed on Facebook, though. Without a doubt, the ongoing pandemic throws a bit of a wrench into the process of actively seeking work, so that component may vary from state to state and could change at any time. You simply create a folder in the SocialFolders directory on your desktop, and its contents will be automatically synced to your account. In most cases, you will file a claim with the state where you most recently worked, but if you recently relocated from another state, that may not be the case. I have spreadsheets stored in Google Docs. You'll be required to answer some questions about any work you completed each week as well as any other income you received. SocialFolders supports Box, Evernote, Facebook, Flickr, Google Docs, Instagram, Photobucket, Picasa, SmugMug, Twitter, and YouTube. In some cases, people who were fired, suspended or asked to take a leave of absence don't qualify for unemployment. SocialFolders is both an application and a Web service: You download a component to your desktop, which creates a SocialFolders folder that you can access via Windows Explorer. Even worse, months later, many jobless people were still desperately trying to cut through all the red tape and the massive volume of people to file their own unemployment claims. If you lost your job due to the pandemic or other reasons, here are the steps to take next to file an unemployment claim online. Step 1: Contact Your State Unemployment Agency Whether you were laid off because of the pandemic or lost your job due to other unforeseen circumstances, filing for unemployment benefits is one way to cover a portion of your monthly bills while you're between jobs. During this interview, you will be asked specific questions about your employment background and other information mentioned in your claim. Minor issue with photo resolution aside, I was quite impressed with SocialFolders. You can use SocialFolders's Web interface to determine how much information you'd like access to (all of your Facebook albums, or only a select few, for example), and the content you've chosen will be automatically downloaded to your desktop. Which is great—until I want access to these files when I'm offline. The company does note that most of the photo-sharing sites it supports lets users download photos in full resolution, though. If you're wondering how to file a claim after all the changes, we can help you figure it out. Set up email notifications, if possible, and watch closely for any messages requesting additional information. Photo Courtesy: svettkd/E+/Getty Images Finally, it's important to keep in mind that unemployment benefits are usually contingent upon a recipient doing their part to actively look for a new job. I found this a very handy way to grab photos of my nieces and nephews that my siblings share on Facebook. Although this rule may vary by state at times due to special circumstances (like a global pandemic), the general rule of thumb is that you're expected to pursue work leads every week and report your work search efforts in your weekly claim. Do you have COVID-19-specific questions about unemployment benefits and stimulus checks? Virtual systems also reduce errors and speed up the claim process. (Exceptions are currently in place to qualify independent contractors and the self-employed, but those rules expire at the end of 2020.) If you want to make sure your claim isn't delayed, be sure to complete all the sections fully and accurately. Our peers over at Ask.com have the answers. Several states conduct telephone interviews before the final ruling to help prevent potential unemployment insurance fraud. The company says that it does not change the resolution of photos when they're downloaded, but that it relies on the API of the social site itself. Since those early days of chaos, most states have adapted and made improvements to handle all the claims. The state agency will provide guidance on that as well as any other issues that could impact your claim. Step 2: Determine Your Eligibility As stated earlier, you need to meet certain criteria in order to be eligible for unemployment benefits. You will need to make sure you have the storage to spare, though, as some of these files could take up plenty of disk space. Texas, for example, waived their work search requirement for many months but reinstated it on November 1. And I have videos stored on YouTube. If you fail to file your weekly claim, your benefits may be delayed or stopped altogether. Then you head to socialfolders.me, where you create an account and start connecting your social services. Finally, keep in mind that unemployment benefits are taxable, so it's generally wise to choose to have taxes withheld from each payment when you first open your claim. Step 5: Collect Your Unemployment Benefits Most claims are processed within two to three calendar weeks or 10 business days, although delays could occur during times of high claim volumes. Nearly all unemployment agencies accept claims online, especially in light of the COVID-19 pandemic. Photo Courtesy: SDI Productions/E+/Getty Images When you file your claim, you will be asked for some personal information, including your name, address(es), social security number (SSN), last 18 months of employment history, a record of wages earned and the reason and dates for your employment termination. While you may be breathing an initial sigh of relief once your initial claim is processed, be sure to maintain your eligibility status by continuing your job search as directed. Step 6: File Your Weekly Payment Request and Keep Up the Job Search Once you start receiving unemployment benefits, you have to file weekly or biweekly (varies by state) payment requests online to be paid — no exceptions. To qualify for unemployment, an individual who lost their job must be eligible for work, able to work and actively seeking employment. Or I could just turn to SocialFolders, a service that offers an idea that's so simple—it syncs the content you have on your social sites to your desktop—I have to wonder why someone didn't think of it before. The online process isn't just helpful for pandemic safety reasons. SocialFolders does more than just create a backup of your files.
